## Lubaczów Industrial Park – a Gate to the East

Lubaczów March 2<sup>nd</sup>, 2017, the Municipal Culture Centre

The event is a continuation of the conference entitled New prospects and forms of cooperation as part of Polish-Ukrainian border network of industrial parks which was held on December 15th, 2015 in Lubaczów. The objective of the conference was to provide information and promote investment areas prepared in Lubaczów town and its Ukrainian partners.

Our self-government was the project leader for the project "Enterprise development through making investment areas of the Lubaczów Municipality and Lubaczów Commune accessible and the recultivation of degraded areas of Yavoriv district and Novyi Rozdil town, Ukraine "which was funded by the European Union within Cross-border Cooperation Programme Poland-Belarus-Ukraine, whose implementation finished at the end of 2015. As a part of the project we managed to prepare areas of total over 23 hectares, designed for production and industrial activity. The value of the executed works exceeds PLN 4.6 million. The investment area offers well-developed technical and transport infrastructure, located far from the residential areas. Pursuant to the Council of Ministers regulation of 29 December 2016 Lubaczów Industrial Park was included into the Special Economic Zone Euro-Park Mielec.

The conference is addressed to:

- entrepreneurs interested in making investments in Lubaczów and other areas of the Special Economic Zone Euro-Park Mielec.
- businessmen from Poland and Ukraine who would like to get current information on possibility of running business activity in both countries,
  - business-related institutions which work to the benefit of entrepreneurs,
  - self-governments interested in attracting business investments in their areas.

We hope that our conference will be a source of current information on economic development plans for Poland, determinant factors and possibility of making investments, prospects for Ukrainian business in Poland and Polish business in Ukraine. We would also like to make it possible for businessmen and representatives of self-government authorities to learn about the process of creating investment offers and standards of investor service, in compliance with the guidelines set forth by the institutions responsible for promoting offers and facilitating contacts between businessmen and self-governments. Our intention is to help businessmen obtain knowledge how to find information necessary to plan and prepare an investment, information about available reliefs and facilitations. During the conference we will tell about the process of creation of Lubaczów Industrial Park and for those who are interested, we offer a study visit to the Park. We tried to select the topics and speakers to make the conference interesting and useful.
